

# CERTIFICATE of WARRANTY

Advanced Home Systems Pty Ltd T/A Gate-A-Mation (ABN 37 615 145 397) warrants the following products installed in Commercial and Industrial situations from defects in material and workmanship subject to the conditions shown below.

- Automation products and Intercom products are covered by this warranty for a period of **ONE YEAR**, unless a clause in our quotation defines a longer period.
- All Other Parts and accessories, including but not limited to, **Clipsal, HPM, Gliderol, Lockwood and FSH**, are for **ONE YEAR** from the date of purchase.

## CONDITIONS

### 1. Warranty

Unless otherwise stated in this warranty, **Gate-A-Mation** will at its sole discretion either replace or repair any, or part of the Product that is defective in material or workmanship within the abovementioned period without charge to the purchaser. Warranty repairs are only conducted on weekdays between 9am and 5pm.

### 2. Other Warranty

Subject to any terms implied by law, this warranty contains the whole of the **Gate-A-Mation** obligations and any agents, officers and employees of such agents and of **Gate-A-Mation** are not authorized to vary or extend the terms of the warranty. The benefits conferred by this warranty are in addition to the conditions and warranties implied by applicable legislation conferring rights upon consumers, which apply only to the extent to which they may not by law be excluded.

### 3. Exclusions

This warranty shall not apply to, or include, any of the following:

Batteries of any sort.

Any defect or failure due to accident, misuse, abuse, negligence, non-observance of any of the instructions supplied with the Product, choice of location, improper installation (other than by an approved **Gate-A-Mation** Installer), or faulty power supply.

Any damage, indirect or incidental, of whatever nature to any part of the product specifically or to the immediate structures that the product is fitted to. This clause specifically includes damage classified as warping, subsidence or collapse of structures or footings not supplied by **Gate-A-Mation**.

If the Product is installed, repaired or serviced by a person who is not qualified.

Failure to obtain proper maintenance for the Product or any associated equipment or machinery.

Failure to pay for the products in full or comply with **Gate-A-Mation** Trading Terms.

If the Product is used other than for any reasonable purpose for which it was manufactured, or is used in a way not specified by **Gate-A-Mation**.

Deterioration due to normal use and exposure, including an act of god involving abnormal environmental conditions such as storm, tempest, lightning strike, floods, electrical surge and extreme heat.

Any freight, packing and insurance expenses relating to transportation of the Product.

Any expenses relating to installation and/or removal of the Product at the absolute discretion of **Gate-A-Mation**.

### 4. Limitations

**Gate-A-Mation** is not liable for any consequential, indirect or accidental loss or damage or for any service not expressly provided herein (including without limitation liability for any loss or damage caused by a fault in the Product or its external wiring connections) and the liability of **Gate-A-Mation** under this warranty is limited to the repair or replacement of defective material or workmanship. Subject to **clause 2**, **Gate-A-Mation** is hereby excluded to the maximum extent permitted by law from all other liability in respect of the Product.

While **Gate-A-Mation** warrants, where applicable, that the Product is free from defects in materials and workmanship under normal use at the time of delivery, **Gate-A-Mation** does not warrant that the Product will meet any user specific requirements or that the operation of the Product will be uninterrupted or error-free.

### 5. Owner's Responsibilities

Maintenance of the Product and associated equipment and/or machinery is the responsibility of the owner. The owner must retain evidence for **Gate-A-Mation** that proper maintenance has been performed on the Product. Claims made during the warranty term will not be accepted if resulting from lack of maintenance rather than faulty material or workmanship.

The owner must operate the Product in accordance with the Operating Instructions (provided).

Upon discovery of a fault the owner must immediately contact **Gate-A-Mation** with full details of the nature of the fault which will ensure the warranty remains valid. (Telephone 8165 0034).

If the Product is found to be working satisfactorily by a **Gate-A-Mation** serviceperson or that the failure is attributable to parts not supplied or installed by **Gate-A-Mation**, a reasonable charge will be made for the cost of time and travel.
